The Department of Defense POW/Missing Personnel Office (DPMO) announced today that the remains of eight U.S. servicemen, missing in action from the Korean War, have been identified and returned to their families for burial with full military honors.

They are Master Sgt. Alfred H. Alonzo Sr., of Tampa, Fla.; Sgt. 1st Class Robert C. Bucheit, of Hamilton, Ohio; Sgt. Francis E. Lindsay, of Esther, Mo.; Cpl. Joseph Gregori, of West Pittston, Pa.; Cpl. Darrell W. Scarbrough, of Fayetteville, W. Va.; Cpl. Homer L. Sisk, Jr., of Ducor, Calif.; Cpl. Charles E. Sizemore, of Rushville, Ind.; and Cpl. William E. Wood, of Moorhead, Minn.; all U.S. Army. Gregori was buried in August; Bucheit was buried in September; Scarbrough, Sisk and Sizemore were buried in October; Alonzo was buried in November; and Lindsay and WoodÕs burial dates are being set by their families.

ATLANTA Ñ For nearly 37 years, memories were all the family of U.S. Army Capt. Herbert C. Crosby had left of the South Georgia soldier who disappeared after his helicopter crashed over Vietnam in 1970.

Military officials recently announced their positive identification of remains belonging to Crosby and two other U.S. servicemen who went down in the helicopter with him.

They are Maj. Frederick J. Ransbottom, of Oklahoma City, Okla.; and Staff Sgt. William E. Skivington Jr.; of Las Vegas, Nev.; both U.S. Army. Ransbottom will be buried in Edmond, Okla. on Jan. 13, and Skivington will be buried at Arlington National Cemetery near Washington, D.C., on Jan. 23. The Final Chapter 30 December, 2006

# Funeral is final chapter for family Vietnam vet's remains return for burial.

Army Master Sgt. Norman Payne moved through the Laotian jungle, searching for other members of his reconnaissance patrol. An enemy attack suddenly filled the night with bullets and confusion.

Payne and the others were part of MACV-SOG (the Military Assistance Command Vietnam Studies and Operations Group) - elite combatants including Green Berets and Navy Seals who conducted highly clandestine operations during the war in Vietnam.

Thirty-eight years later, the former Clevelander and Special Forces soldier is coming home, following a search that started in 1993 and ended with identification of Payne's remains this year.

# Stone Becomes Memorial 15 January, 2007

Military mom spurs town to make POW-MIA memorial official

MEREDITH, N.H. --A stone in Heskey Park has long served as an informal memorial to prisoners of war and missing soldiers, and soon it will soon become official, thanks to a military mom. The chairman of the Northeast POW-MIA Network holds a weekly vigil at the stone, and the annual Freedom Ride, part of Laconia's Motorcycle Week each June, also ends at the stone.

Holly Tetreault says her son, who's in the Navy, was visiting Washington recently when he saw vendors outside the Vietnam memorial selling paintings of the stone. She says that's proof it has become a nationally recognized symbol. Tetreault got permission from the board of selectmen to put a bronze plaque on the stone with the POW-MIA logo and the words, "To all POW-MIA's and their families ... past, present, future."

The plaque will be paid for through private donations.

## Attention to Orders Details for Tomorrow January 2007

A new year has begun and with all the holidays behind and so goes much of the "good will toward men." We see this at Minnesota Assistance Council for Veterans (MACV-Duluth) office as so many wonderful people have come out to help us in our work with veterans and their families that are at risk of homelessness, those experiencing homelessness, and veterans in crisis. We are grateful to all those who have made the lives of those we work with better at what can be a difficult time of the year. Now comes January. For many it brings hope for a new year, and for others a long lonely winter.

While this true for those we work with this is also true for those in our military and their families. We know that the 148<sup>th</sup> will be deploying almost half of its total complement for tours of weeks up to 179 days missions. Families, businesses, and communities will be impacted. We need to be supportive of them all. Deployment is a long process. It begins with predeployment, deployment, and post deployment. We as members of the greater community need to be involved. That includes family, work, friends (real friends), schools, and Churches. Lets take this seriously. This is a time when we can extend ourselves to other. Lets not get callas to the ebb and flow of our Military. I have seen this already when last month twenty-three members of the Navel Reserve CB's unit came home with an event at the Depot. Where were Media and the pubic support for these troops and their families?

At MACV-Duluth office we have seen more new individuals and families from the current war so far than we ever expected to see so soon after returning. Historically issues of PTSD, disenfranchisement, and personal hardships take years to develop, but that is not as true today as it has been in the past. We are dealing with in many cased an older military many with families, established employment, and settled lifestyles. These people have to come back to an every changing world and finding it difficult to find a good fit. At MACV-Duluth do what we do very well using all the resources that we have in the community.

We don't do it alone. This is where the community needs to be in tune as well. As we see these individuals, and families we need to be open to their needs. Here are a few suggestions for you:

- There are questions that often come from a morbid courtesy. I stopped one such conversation. The person asking meant to do no harm and she had no idea what harm that could cause the person that she had questioned. Never ask anyone of what it was like to kill somebody? What was it like to see and be there? Instead do be there for the individuals when they need to talk, but don't push.
- · After the yellow ribbons are gone be there as a friend for the quite times. There is a sense of loss that being at home while others are still fighting. It often a personal struggle between being home with family and your military family still in harms way. It is a struggle between a job well done and one that is not completed. It is a struggle between what the media and the politicians are saying, and the reality of the boots on the ground.
- · Churches! I want to address this. NO ONE did more harm to the returning soldiers and their families when we returned from Vietnam than did the church. For many, war brings conflict that shakes and even destroys our basic belief system and that includes our belief in God. What happened to those of my generation was devastating. What we hope for this generation of soldiers is that the Church to redeem itself. This is a whole topic in itself for another time, but let it be said that the church as a whole needs to learn from it's past.

The country has learned from its past, but there is still much to learn. In many cases those who the country had treated so badly when we returned from Vietnam are leading the charge today to not let this happen again. Vietnam Veterans of America has at its core beliefs that another generation will never have to endure what we endured. I see this in programs like "Beyond the Yellow Ribbon" started here in Minnesota by Chaplain Morris of the Army National Guard. The establishment of Family Resources centers like we have right here at the 148<sup>th</sup>. The VA as a whole has reacted very quickly with the establishing of four politrauma units nation wide, one being at Ft. Snelling. The Twin Ports Outpatient Clinic is working extremely hard to meet the needs of returning troops to our area. The Vets Center has expanded physically and staff wise to meet the need for those in the reintegration process. All this increasable work while Congress holds the VA hostage in the budget process. There is much to do. As a provider of these services at times it gets overwhelming. What I am asking you to do as in these new years is not forget those who we serve. The soldiers that are being deployed, been deployed, and now returned, their families, and those that are there to provide the services needed. They need you to be honest, be supportive give of your time, and resources and keep them all in your prayers.
